Register your numbers to block scam calls and texts before they reach your phone.

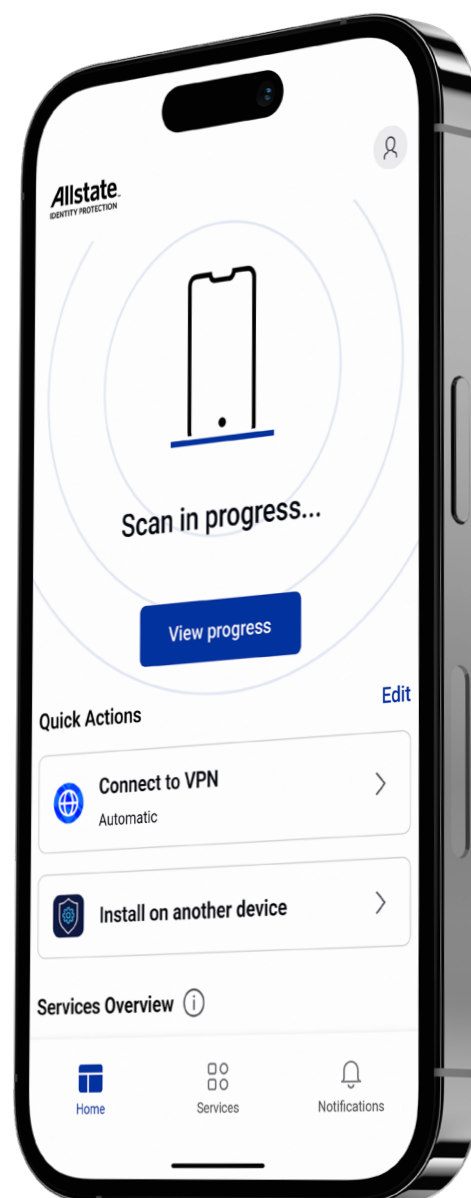
