- **Domestic Partnership Agreement**

You want your partner to have access to your health information.
- **Hospital Visit Authorization**  
You want to document your wishes regarding your partner's rights to visit you in a medical facility.
- **Pre-Birth Parentage Order**  
You are using a surrogate to have a baby and you need to establish legal parentage over the baby.
- **School Administrative Hearings**  
Your child has a disability, and the school is not providing adequate accommodations.
- **Surrogacy Agreement**  
You and your partner want to have a baby through surrogacy and need help conducting the evaluation, writing an agreement and negotiating payment.

## Reduced Fee Services
